What will I pay?

New platform

- Platform fee of **0.55%** per annum up to £500K; **0.45%** between £500K & £1m; **0.35%** for £1m+
- Typical Total Ongoing Charges Figure (TOC) of **1.03%** per annum per fund
- Fees payable from the cash account

Existing Aegon arrangement

- Platform fee of **0.6%** per annum up to £500K; **0.5%** between £500K & £1m; **0.4%** for £1m+
- Typical Total Ongoing Charges Figure (TOC) of **1.03%** per annum per fund
- Fees payable from cash account

What are the costs?

Transferring your investments are typically **free of charge** but some providers do apply an exit fee.

Below is a table which shows a **typical example** of what you are paying currently and what you may pay if you transfer to the Charles Stanley Platform.

* Total Ongoing Charges Figure (TOC) shown are inclusive of the fund ongoing charges figure (OCF), transaction costs and incidental costs. For illustrative purposes, we have used the weighted average costs and charges of the five most purchased funds on our platform for the three month period November 2018 to January 2019.
